4. FIRST AID MEASURES

Emergency and First Aid Procedures: Remove from exposure and move to fresh air immediately.

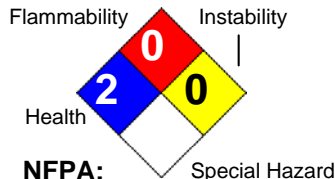
